Dear Mike Young:

This is to confirm that at the Legislative Hearing on June 4, 2024, Legislative Hearing Officer Marcia Moermond recommended that the City Council waive the Vacant Building fee for 90 days (to September 8, 2024) and allow permits to be pulled.

As discussed in the hearing, **reach out to Building Inspector Clint Zane** to discuss remaining permits necessary to complete the project. As indicated in your Code Compliance Inspection Report a building permit is required for certain items. Noted below, there are also two plumbing permits that need to be finaled, as well as an electrical permit, before the Code Compliance certificate will be issued.
