## **International Association of Fire Fighters Local 21**

This MOA is entered into by the City of Saint Paul (hereinafter "City") and International Association of Fire Fighters, Local 21 (hereinafter "Union") for the purpose of revising the previous wage adjustment in the 2023 – 2025 collective bargaining agreement. The parties recognize the benefit to City in the hiring and retention of Emergency Medical Technicians. To attract qualified employees, to promote employee retention, and to preserve labor stability in the workforce, the parties agree to the following:

1) Effective at the beginning of the closest pay period following council ratification, the salary ranges indicated below shall supersede Appendix A of the contract as follows in reference to the Emergency Medical Technician title only:

Salary ranges applicable to titles covered by this Agreement shall be as shown below:

Effective January 1, 2023: 1.5% ATB
Effective July 1, 2023: 2% ATB
Effective January 1, 2024: 2% ATB
Effective July 1, 2024: 2% ATB
Effective January 1, 2025: 2% ATB
Effective July 1, 2025: 1.5% ATB
