Please be advised that we may enter your apartment to pre-walk the condition of your apartment. If there are any damages, lease fulfillment fees, or cleaning charges, you will be notified of any monies due. For your information, the final month's rent (not including utilities or buyout fees) in the amount of due on 7/1/2024. If you receive your monthly statement that shows a full month, please pay the pro-rate listed above and the utilities from the statement. We ask upon moving out, you:
