City Councilmembers:

I am writing to express my opposition to the rezoning under consideration that will allow multiple dwellings on all lots in St. Paul.

I have concerns re: off-street parking and general parking provisions. Narrow streets such as Banfil in the W. 7th area, lower Rice St., Railroad Island, other areas of the East Side, etc. Parking has been banned on some streets, others contain one-sided parking, and still there are parking issues. Banfil St. is 27 feet wide. Some streets in the lower Rice St. area are more narrow, and many of these areas contain older, single-family housing that has been converted to multiple occupancy rentals with no off-street parking provided. The City Council has removed minimum parking requirements for businesses, and this lack of parking causes congestion and other issues in residential areas that are used as employee "parking lots". Of particular concern is winter street maintenance.

I am also opposed to Councilmember Noecker's amendment increasing height limits for structures.

Hello,

I just want to put a concern I have about potential zoning changes. If the city allows more dense housing without mandatory off street parking, our streets will be adversely affected in the winter. St.

Paul's streets in winter are already nearly impassable after a few snow falls. I believe the big cause of this is cars parked on the street despite snow emergency rules. Suburban streets don't have the same problems because their residents, for the most part, do not park on the street. Adding denser housing without off street parking requirements will just make this worse in St. Paul.

I (now retired) was the transportation manager for a charter school on the east side. One winter we had a bus get stuck on a street because parked cars had encroached into the street so much that the bus couldn't get past.

Please consider the side effects on our winter streets before increasing the density of housing without off street parking requirements.
