Just passing along a couple emails I received from this person, which are both attached to this email. Not sure if they should be added to the record for the RLH TA file, so I wanted to share just in case. There's a lot of stuff in them, and I did my best to summarize them below. None of this involves me stating facts, but just reiterating what she says in her emails.

- Email 1
 - She complains about paying \$3,800 in garbage fees for when she was out of the country from 10/20/2019 – 10/24/2024. She says she went through the necessary process for holding service. She included numerous attachments of her sending a hold service form, but then showed a photo of the form and it did not appear to be filled out, so it is unclear if she actually ever sent a completed hold service form. It looks like a City employee was unable to open an attachment, based on a 11/29/2023 email. Not sure what that attachment was though.
 - She also complains about paying thousands of dollars in water charges during that same time period, saying that the water was turned off during that time.
 - She says she is homeless and living in an apartment
 - She says she has called police about insurance fraud
 - There is something I can't understand at the end of it.
- Email 2 largely reiterates the same points
