NOTICE OF PUBLIC HEARING Sound Level Variance

Night Nation Run- Twin Cities May 20, 2023 by Allianz Field

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. <u>Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be</u>

viewed by the occupants.

Description of Variance:

Location: Running Course Streets bordered by Asbury St, Simpson St, St Anthony Ave and Pascal St directing sound towards the Stadium and large parking lots by 400 Snelling Ave N. – Allianz Field Area Noise Source: Zacharia Litzelswope, Allianz Field Director, Events and Guest Experience, has requested a sound level variance, for 95 dBA at no specified distance to present amplified sound with use of a sound system for a Night Nation Run- Twin Cities Event on May 20, 2023 by Allianz Field outside of 400 Snelling Ave. N- Allianz Field. The variance is requested for the hours of 6:00 p.m. to 10:30 p.m. on May 20, 2023 with pre-event sound checks between 12:00 p.m. and 6:00 p.m. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variance shall be for the hours of 6:00 p.m. to 10:30 p.m. on Saturday, May 20, 2023 with pre-event sound checks between 12:00 p.m. and 6:00 p.m. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from all sound sources on May 20, 2023. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:30 p.m. on May 20, 2023, the event date.

Submit comments for Public Hearing electronically. The public may comment on public hearing items in person, in writing or via voicemail. Any comments and materials submitted by 12:00 pm of the day before the meeting, Tuesday, April 18, 2023, will be attached to the public record and available for review by the City Council.
