On April 9, 2024, the City Council is scheduled to hear a request for a sound level variance from the University of St. Thomas. Section 293.09 (e) 3 of the Legislative Code contains the standard that the Council must use when considering this request. That section provides: (3) The variance may be granted or modified only if the council finds that full compliance with the requirements of this chapter would constitute an unreasonable hardship on the applicant, on other persons, or on the community. The council shall balance the hardship to the applicant against the adverse impact on the health, safety and welfare of the persons affected, the adverse impact on property affected, and any other adverse effects of granting the variance.

The application filed by the University does not set out the unreasonable hardship that the Code requires. Put simply the University has not demonstrated that the school or the spectators at the football game will suffer unreasonably if the noise variance is not granted. On the other hand, the harm that will fall on the neighborhood residents is exactly that which the Code prohibits, i.e., noise above a certain level. The balance of harms tips in favor of the neighborhood. The requested variance should be denied.

Additional evidence that the required hardship is not present is found in the above attached file. In summary this correspondence between the undersigned and a University official reveals that football games at the University can be played without the variance here sought at no harm to the audience.

Finaly, the practice of granting sound level variances in disregard of the Code may be found to constitute a denial of due process. In turn that may subject the City and those officials who engage in such conduct to liability. I would ask that you consult with your legal counsel on this point.
