On our call, you mentioned that this notice I'm responding to was the second of 2(?), and that another was sent to several neighbors sometime prior to now. This notice that I am responding to today is the first I have ever heard about the entire matter.

The vehicle responsible for this notice is not my property, and was towed from an address that is also not my property. The parking behind my boxed in backyard is not accessible or owed by me. My property (809 Charles Ave) has no alley access whatsoever. That parking spot appears to serve both properties that box me in in back. Those properties are:

Some ongoing matters I'm dealing with include dog feces from unleashed ESA animals, ongoing tenant trash in front and back of the green 6 plex, and duplex trees interfering with power lines.
