Fire damage isolated to front bedroom, main floor. Smoke damage throughout dwelling. Door to front bedroom was partially closed when crews arrived. Door was removed during fire attack.

The main room of involvement was extremely unkept. Clothing, electronics and other materials were found everywhere. Fire started near the floor along the bravo wall, under the windows. No accelerants noted when monitoring.

Windows broken on alpha / bravo corner. Crews reported only one window broken on arrival with fire showing. Other windows broken with interior fire attack.

# Conclusion

## Case Conclusion

After examination of the fire scene, observation of fire patterns of both movement and intensity and interviews conducted, it is my opinion the fire began in the alpha side bedroom, first floor. The area of origin was at the floor level, bravo side of room. The first fuel/material ignited was most likely fabric / clothing. The ignition source was most likely a candle. The oxidant was normal atmospheric air. The action that brought these items together was an unattended candle. No accelerants noted when monitoring. The classification of fire cause is accidental. This concludes my investigation and report.
