NORTH SIDE ACTIVATION - GREAT LAWN SITE MAP

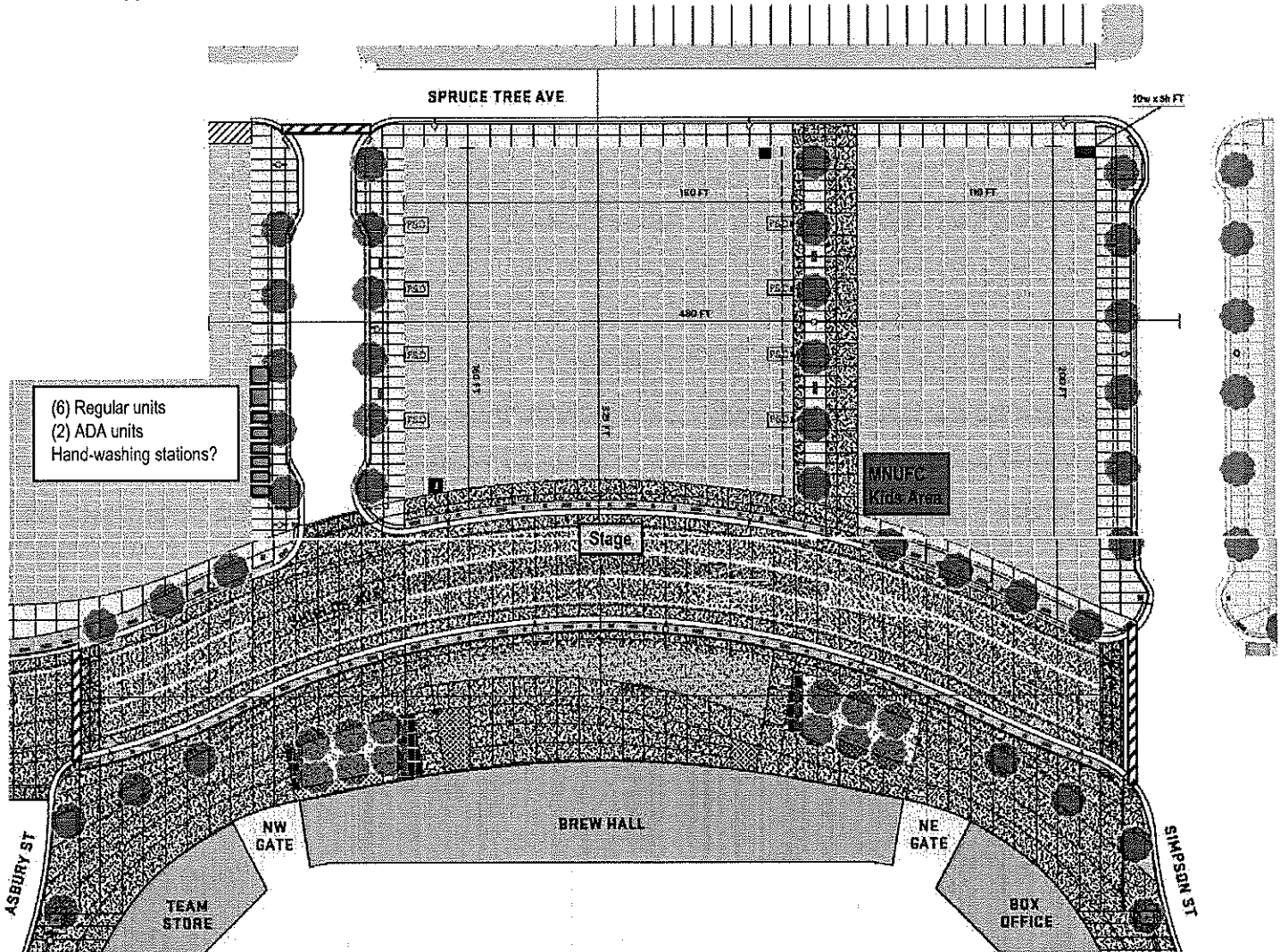
