Do you have more than 40 hours of compensatory time accumulated?

You have until March 31 to use the hours over 40 or the overage will be cashed out for you.

You can accrue up to 150 hours of comp time a year and use 120 hours. The reporting year ends on

March 31 and you are only allowed to carry over 40 hours into the new reporting year.
