Saint Paul Legislative Code provides that no building shall be occupied without a Certificate of Occupancy. In order to re-occupy the building, the following deficiencies (if applicable) must be corrected and a complete Certificate of Occupancy inspection will be required.

- 1. Exterior Throughout SPLC 34.09 (3), 34.32 (3) Repair and maintain the door latch.-
- 2. Exterior Throughout SPLC 34.09 (1) b,c, 34.33 (1) b, c Provide and maintain all exterior walls free from holes and deterioration. All wood exterior unprotected surfaces must be painted or protected from the elements and maintained in a professional manner free from chipped or peeling paint.-
- 3. Exterior Throughout SPLC 34.09 (3), 34.32 (3) Repair and maintain the window in good condition.-
- 4. Exterior Screen Door Ext. Door SPLC 34.09 (3), 34.33 (3) Repair and maintain the door in good condition.- Repair or replace broken screen door.
- 5. Throughout SPLC 34.19 <u>Provide access to the inspector to all areas of the building for a full inspection 10/01/15 at 11:00am.</u>
- 6. SPLC 34.11 (6), 34.34 (3) Provide service of heating facility by a licensed contractor which must include a carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office.

7. SPLC 39.02(c) - Complete and sign the smoke detector affidavit and return it to this office.
