In her voicemail, Marcia asked that I get in touch with you. I'm sorry we didn't connect on the phone on Tuesday for the hearing. I came out of another meeting a little late and missed the call.

Here is an update on this project:

1. To date, Northern Value Group has spent $\$ 128,474$ on the cleanout, demolition, permits, labor and materials, and maintenance of this property.
2. A progress inspection has been scheduled with Clint Zane for Tuesday 1/23 at 11am.
3. We had a delay getting the power restored in this property because it required new service panels to be installed by the electrician before we could schedule Xcel to reconnect the service, but temporary power has been restored.
4. A new forced air furnace has been installed in the upper unit.
5. The lower unit furnace is being repaired
6. The front 2-story porch has been completely removed and rebuilt (and inspected by Mr. Zane)
7. The back deck and stairs have been completely removed and rebuilt. (and inspected by Mr. Zane)
8. The condemned garage has been demolished and removed
9. New entry doors have been installed for security.
10. The front steps leading to the city sidewalk have been mud-jacked and leveled.
