Qamar,

I will reiterate what I explained when you emailed in early January of this year:

If you do not want to use or pay for garbage services, <u>you need to request a hold</u>. This process is outlined on our website: <u>https://www.stpaul.gov/departments/public-works/residential-garbage/garbage-service-holds</u>. Because I have no record of a hold request, I cannot waive this bill for you.

Background on why you received these notices:

Your Quarterly bills since last April went unpaid. As a result, Waste Management sent your delinquent bills to the City which the City paid on your behalf (that is why your payment history with Waste Management shows a zero balance). Therefore, you currently owe the City \$256.41 for 2023 and \$86.49 for 2024.

If you paid the hauler within the service period and believe the assessment was applied in error, please provide verification of payment and we can research removing the assessment. **If you would like to contest the assessment for any reason, you can request a legislative hearing.** To do that you, you can reply to this email stating you'd like to appeal.

If you'd like to pay the assessment, listed on your letter from the City, there is a website (<u>stpaul.gov/assessments</u>) where you may pay online. If you prefer to send a check, there is also an address listed where you may send your payment:
