This is to confirm that as discussed at your May 22, 2023 Legislative Hearing, this matter will go before the City Council **on June 7, 2023 at 3:30 p.m. in room 300 City Hall/Courthouse**. If the property *has not* received its Code Compliance certificate at that time, the matter will be continued to Council Public Hearing July 11, 2023 at 3:30 p.m. At that time the nuisance should be abated and the matter resolved.

As mentioned, you have outstanding permits that need to be finaled. Information on those is below. You or your contractor(s) should reach out to the Inspector to have those inspections done as soon as possible.
