**NARRATIVE**

No ICC video available

On 7/17/14 at 01:10 hours, we Squad 210T (Yarusso/ Sweeney) responded to an alarm at Quality Insurance Service (236 Larpentur Ave. W, CP: 651-489-1347).

Dispatch informed us that an audible alarm which covers a motion detector had been set off. WH International (WP: 800-858-7811) reported the alarm to dispatch.

Upon arrival, we noticed a window in the front entrance had been shattered. The window was located directly next to the front door of the entrance. It appeared suspects were able to gain entry into the business by unlocking the front door through the broken window.

We went into the business with assisting K9 Officer D. Galli and his canine partner. We cleared the business with assistance of the canine. Nobody was found inside. It did not appear anything was disturbed inside. Without the key holder response we were unable to tell if anything was missing. There were no visible security cameras inside the business.

Dispatch was unable to get a hold of the key holder. I asked data to have a board-up crew come out to the scene to secure the building.

I took pictures of the scene. I taped my business card with case number to the front storefront window, next to the main entrance.

The board-up crew arrived on scene and made the building secure.

I uploaded the pictures to media vault.
