The Department of Safety and Inspections (DSI) recommends the following conditions: 1) The variance shall be for the hours of 7:00 a.m. to 12:00 p.m., with a pre-event sound check from 7:00 a.m. until 7:30 a.m. on Saturday, January 30, 2016. 2 All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from the sound source. 3) The applicant shall provide personnel and equipment to conduct continuous sound level monitoring during the event. 4) All electronically powered sound equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 12:00 p.m. on the event date.
