I purchased this property on June 30, 2015. I invested all my life savings in this property because of the zoning and already active auto body license. After I purchased the property I could not evict tenants without giving them 2 months of notice. So I took over the property on September 1, 2015. On August 10 I applied to transfer the same existing license to my business name. This was the same license that was already active for this property and I used the same existing plan. The city also allowed me to continue using the existing license while my new license application was in process. One family complained about my license application and I was called to a neighborhood hearing. The Land Use Committee recommended me to address that family's concerns by making the necessary paint booth repairs. The Land Use Committee specifically asked me to hire an inspector for the paint booth to find out if there are any issues. I hired Wencl Services, Inc. Wencle Services found 2 issues and they fixed both of them immediately. Their certification and invoices are attached with this letter. City of St. Paul fire code inspector, Dave Berglund was also amazed the improvements we made to the paint booth. At the October 26, 2015 District 6 Planning Council's Land Use Task Force meeting, the same family was still complaining without any reason while there were over 30 neighborhood members who showed up to support the approval of this license application. All members of the Land Use Committee overwhelmingly voted for the approval of this license. The copy of their recommendation is also attached. I transformed both the building and the business. This property and business were in disarray when I purchased the property and I put my own money to make countless corrections. As you can see from attached invoices and the letter I wrote to the Land Use Committee, I did more than required by the city. You have to understand that I am NOT applying a new license for a new building. All I am asking is to transfer already active and existing license to my business name. The existing license is still active and the city did not revoke it. Today I am using this active license to run my business and nothing is wrong with it. The only thing I did was to improve the paint booth, the compliance, and the building. I am made all these improvements to this building and I am more qualified to have this license than the previous license holder. It does not make any sense to even take this long to approve my license application. There were many businesses owners who applied this license for this

building over the years and none of them went through what I am going through right now. The owner of the current active license did not even go to a neighborhood hearing and his license was immediately approved. I already lost money and business because of this process and all I am asking is to get this license approved so I can hire new employees and create jobs in this neighborhood.

### **City Inspector**

On November 4, 2015 a city inspector came to my business and harassed me, insulted me, and threated me. She admitted the reason she was at my business was to derail my license application. When she couldn't find any violations she tried to make something up. She said you have 12 cars in the lot. She also said there was a garbage/scrap metal in my lot. First, the 2 extra cars she is talking about were cars I just pulled from the repair stall and they were ready to be picked up. The 2 customers who owned these cars were standing there and waiting for their keys. It is unsafe to let customers go inside the repair area so they can pull their own cars. It is also violation to park customer's cars on the street. Second, the scrap metal were exactly where City of St. Paul fire code inspector told me to put. Nevertheless, I asked her to give me 2 minutes so I can have the 2 customers drive off their 2 cars while I am removing the scrap metal into inside of the building. She refused and ran away. The 2 cars left and I removed the scrap metal in less than 2 minutes. I kept calling her in the next few days but she didn't answer her phone. I left her 5 different voicemail messages asking her to either call me back or come back to see that everything is the way she wanted. She finally answered her phone and said she will not come back to give me a clearance. She said all I need to do is to bring pictures to the hearing to prove I corrected all the mistakes. Even though I don't believe I made any violations, attached are pictures that show the lot is clean and there are no more than 10 vehicles in the lot. These vehicles are all for my customers and employees. We don't park on the street in front of us. This shouldn't be an issue today because all the correction she requested were made and picture to prove that are in front of you. When I bought this property there were more than 20 cars in the lot and the city didn't even care.

These 4 reasons that will help you approve this license application today:

- 1. At the October 26, 2015 District 6 Planning Council's Land Use Task Force meeting, all members overwhelmingly voted for the approval of this license.
- 2. Certification from Wencl Services, Inc shows the paint booth is running property and it is up to code.
- 3. Attached pictures and video I have in my phone prove the lot is clean and number of vehicles parked in the lot are no more than the city allows.

4. All I am asking is to transfer the active and existing license to my business name. All I did was to improve everything the paint booth, the compliance, and the property.

### FIELD REPORT

Job Site: Jose's Auto Body 363 Atwater Street St Paul, MN 55017

On September 1, 2015 Wencl Services, Inc. was contracted to inspect your paint booth system to verify that the system was working as required by Section 502.7 of the 2015 Minnesota Mechanical and Fuel Code. We found two (2) non-compliant issues with the paint booth.

- 1. The booth was running below 100 foot per minute (FPM) face velocity. We discovered that the belt on the exhaust fan was worn and needed replacement. The belt was replaced. The airflow was tested and found to be maintaining 100FPM face velocity.
- 2. The exhaust duct was terminated with a goose neck fitting above the roof. We replaced this fitting with an up-blast ventilator.

This work was completed on September 15, 2015. As of September 15, 2015 the booth was running properly and was in compliance with Section 502.7 of the 2015 Minnesota Mechanical and Fuel Code.


