Hi Marcia,

I just wanted to provide a quick update on this property, as certain required conditions were due today. The code compliance inspection request has been submitted and paid for (I sent it over via fax earlier today). The \$5,000.00 performance deposit was approved by my client's internal hierarchy, and was with Wells Fargo's accounting team for issuance and submission to the City as of yesterday; however, I have not yet received confirmation from my client whether the check and deposit form have been delivered/received by the City. Once confirmed, I will advise.

My hope is that – with these two conditions being met – you will be able to recommend to the City Council that this matter be continued to the September 13, 2016 legislative hearings per your July 14<sup>th</sup> letter in this matter.
