Location: Macalester College, Athletic Field West of the Leonard Center Gym, 1600 Grand Avenue

Noise Source: Macalester College, represented by Lerren Tyler, Student Activities Coordinator, has requested a sound level variance in order to present outdoor music at the Athletic Field West of the Leonard Center Gym at 1600 Grand Avenue from 3:30 p.m. until 8:00 p.m., with a pre-event sound check from 11:00 a.m. until 3:00 p.m. on Saturday, April 15, 2017 for Springfest. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The variance shall be for the hours of 3:30 p.m. to 8:00 p.m., with a pre-event sound check from 11:00 a.m. until 3:00 p.m. on April 15, 2017. 2. All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 8:00 p.m. on the event date.
