Noise Source: The ALS Association Minnesota North Dakota South Dakota Chapter, ALS Super Hero 5K/10K Dash, represented by Ryan Stauff, Vice President of Development, has requested a sound level variance, at no specified sound level limit or distance, in order to present music and announcements at Lake Phalen Park from 8:00 a.m. until 12:00 p.m., with a pre-event sound check at 8:00 a.m., on Saturday, May 6, 2017. The Department of Safety and Inspections (DSI) recommends the following conditions: 1. The variance shall be for the hours of 8:00 a.m. to 12:00 p.m. on Saturday, May 6, 2017. 2. All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured at 50 feet from the sound source. 3. The applicant shall provide personnel and equipment to monitor sound level limits as specified in Condition #2. 4. All electronically powered sound equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 12:00 p.m. on the event date.
