1. Exterior - (Includes all except 6,7,8,9 & 11)

Repair the defective sewer line and abate rodents. A permit is required. For permit information, list of contractors licensed in St. Paul, or location of defective sewer please call 651- 266- 6234. If this nuisance is not repaired by the deadline, the City will repair the defective sewer and access all costs to your property. We appreciate your cooperation in the quick repair of the broken sewer line and extermination of rodent infestation. Thank you! Comply before February 7, 2018

If you do not correct the nuisance or file an appeal before February 07, 2018 , the City will correct the nuisance and charge all costs, including boarding costs, against the property as a special assessment to be collected in the same way as property taxes.

Charges: If the City corrects the nuisance, the charges will include the cost of correction, inspection, travel time, equipments, etc. The rate will be approximately \$260 per hour plus expensed for abatement.
