Dear Property Representative:

Your building was inspected for the renewal of the Certificate of Occupancy. Since you have failed to comply with the applicable requirements, it has become necessary to revoke the Certificate of Occupancy in accordance with Section 40.06 of the Saint Paul Legislative Code. A reinspection will be made on April 30, 2018 at 9:30 am or the property vacated.

The Saint Paul Legislative Code further provides that no building shall be occupied without a Certificate of Occupancy. Failure to immediately complete the following deficiency list or the building vacated may result in a criminal citation.

DEFICIENCY LIST

- 1. MFGC 501.15 Effective immediately, an approved metallic liner shall be installed in a masonry chimneys used to vent gas appliances as stated in the Minnesota Fuel Gas Code.-
- 2. MFGC 503.5.3 Chimney liners shall be required for masonry chimney flues serving listed gas appliances with draft hoods, Category 1 appliances and other gas appliances listed for type B vents as stated in the MFGC and installed per Chapter 5 of the MFGC for masonry chimneys.
