FIRE INSPECTION CORRECTION NOTICE

Dear Property Representative:

Your building was inspected on October 30, 2012 for the renewal of your Fire Certificate of Occupancy. Approval for occupancy will be granted upon compliance with the following deficiency list. The items on the list must be corrected prior to the re-inspection date.

A re-inspection will be made on November 30, 2012 at 9:30 AM.

Failure to comply may result in a criminal citation or the revocation of the Fire Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Fire Certificate of Occupancy. The code also provides for the assessment of additional re-inspection fees.

YOU WILL BE RESPONSIBLE FOR NOTIFYING TENANTS IF ANY OF THE FOLLOWING LIST OF DEFICIENCIES ARE THEIR RESPONSIBILITY.

DEFICIENCY LIST

1. INTERIOR - MAIN EXIT - MSFC 1003.2.2.5 - Post the occupant load on an approved sign in a conspicuous location near the main exit of the room.
-The sanctuary assembly area is not to exceed 49 occupants. The occupancy load will be increased once a second code compliant exit becomes available.

2. INTERIOR - MAIN LEVEL - MSFC 1005.2 - Provide an approved additional means of egress due to an inadequate number of exits.
-Provide a second code compliant exit on the main level. A second exit is required due to the fact that the occupant load in the sanctuary exceeds 50 occupants. This work must be done under permit. Call DSI at (651) 266-9090.
3. INTERIOR - MAIN LEVEL - MSFC 1010.3 - Provide and maintain approved external or internal lighting of the exit sign.
-Provide an approved exit sign above the second required exit on the main level.
4. INTERIOR - MAIN LEVEL BY THE STAIRWAY LEADING TO LOWER LEVEL - MSFC 1027.20 Stairway discharge identification. A stairway in an exit enclosure that continues below the level of exit discharge shall be arranged and marked to make the direction of egress to a public way readily identifiable.
-Provide an approved sign stating 'NO EXIT'

You have the right to appeal these orders to the Legislative Hearing Officer.
