Subject: Re: Order to Vacate

Ms. Moermond,

Yesterday you called me when I was waiting for my mother's medical providers to call me regarding my mother's medical needs. I was emotionally and physically exhausted and you demanded I participate in a hearing right there and then despite my having requested, in writing, that it be rescheduled for another week.

Over the phone you informed me you were ordering me to leave my home, and were choosing to categorize my having a need for sewer main work to be done as a life-threatening emergency, and that I had to leave. You said something about Thursday and you said something about Friday. I'm not sure what you said or what you meant and I most certainly don't know what the rules for implementation of this are.

As a citizen of the United States, I'm supposed to have due process and I'm supposed to know what I'm charged with and what the punishment is and what all the fine print is.

I have medical appointments critical to my health and wellbeing, long drives to visit my mother, and exhaustion due to the stress you and Steve Ubl are putting me through.

What precisely have you, in your quasi-official actions as a quasi-member of the judicial

system in our country ordered? How am I to obey your quasi-judicial orders when I don't have them in writing?

May my cat stay in my home? My cat has feline aids, and is not allowed at boarding places.

Do you expect me to stay at a homeless shelter?

My budget cannot afford two homes.

Am I allowed to sleep in a tent in my yard?

Am I allowed to stop at my home to pick up necessities that I am too tired to pack up?

Do you intend to get a warrant to break into my home, in order to destroy evidence of malfeasance?

Do you intend to humiliate me by putting a placard on my front door or by boarding up my house?

Do you intend to sabotage my legal situation involving John Meyer and Viking Exteriors, by making it impossible for me to access the files in my home?

I'm exhausted and my arthritis is flaring. I don't feel well enough to move my computer. I'm too tired to think. I want to be visiting my dying mother, but I need to make sure that you don't get away with accomplishing what you can do with the trajectory that you are on, which would essentially destroy my life.

I've withstood ten years of malfeasance and abuses. I'm tired.

Why don't you have the decency to put your orders in writing, and provide the details of them?

I don't remember what you said and I don't know what is required of me.

I don't want you to take my house from me.

What do I have to do to prevent you from doing irreparable harm to me that I'm not capable of surmounting? Due to the combination of actions against me and failure to act against contractors who violate codes and ordinances, my legal affairs are a mess and require my attention.

How can I attend to the critical legal affairs in my life, all of which were caused by Steve Ubl and his underlings, when you have ordered me to leave my home at a time when I am sick, exhausted, in grief at the impending loss of my mother, and am too poor to pay for lodging and meals elsewhere?

Do you intend to turn off the electricity and let the food in my refrigerator and freezer spoil?

Do you intend to order me arrested and prosecute me if I pick something up from my house?

How am I to hire someone to fix the sewer, if my house is locked up and I'm not allowed in it?

What about the insurance adjusters who want to come to my home on Thursday, tomorrow?

Since you have stated you intend to violate my constitutional rights and enforce your violations of my rights, it is incumbent upon you to provide the details of the rules that you have created in order to achieve your purposes.

By the way, are you aware that Public Works does NOT have a policy of condemning the homes of people who are waiting to have their sewer lines repaired, and that Public Works does NOT have a policy of demanding access to people's property for the purposes of acquiring evidence against them to be used in quasi-judicial proceedings run by quasi-judicial hearing officers with little to no legal training?

Why is it that you have singled me out for your special emergency procedures? Can there be any explanation other than you are conspiring with Steve Ubl to violate my Constitutional rights?

By the way, I've spent all day working on this letter and have not had time to eat anything. I haven't had time to get any exercise, either. The stresses you have put on me are destructive to what is left of my health, after ten plus years of being subjected to malfeasance under color of law by corrupt officials who lack sufficient oversight to ensure they are following the law.

And, I did not visit my mother yesterday, as planned, and I have not visited my mother today. Right now, I'm utterly exhausted, and have a long drive ahead of me. I'll be even more exhausted when I get home. And, I have no idea what it is that you expect of me.
