Dear Sir or Madam:

I am writing today to seek a variance on my window dimensions at 407 Toronto Street. This is a rental property that became code compliant in September of 2011. Before that time it was a category 2 vacant building.

In the three upstairs bedrooms the windows measure 18.5 inches x 25 inches. In each bedroom there are at least two sets of these double hung windows and in the master bedroom, there are three sets of double hung windows. These are newer replacement vinyl windows, which were replaced in the past ten years. (Before I owned the property.) These windows are all in fine working order and have tabs so they can be taken out of the space easily.

This building also has <u>two</u> staircases. One at the front of the building, and the other in the rear. Both are 40 inches wide. In the case of an emergency, occupants will have two choices to exit the building from upstairs. There are also two doors in the building on the main floor.

Finally, this building was completely inspected by Jim Seger and the inspectors from the Department of Safety and Inspections prior to being certified as code compliant.

In bringing this building to be code compliant I have invested over 60,000 dollars and 15 months of time. Please grant this variance for 407 Toronto.

- 1. BEDROOMS MSFC1026.1 Provide and maintain an approved escape window from each sleeping room. The minimum size must be 5 square feet of glazed area with a minimum of 24 inches of openable height and 20 inches of openable width. With a finished sill height not more than 48 inches. This work may require permit(s). Call DSI at (651)- 266-9090. WINDOW DIMENSIONS, 18 1/2 INCHES WIDE X 25 INCHES HIGH WITH A GLAZED AREA OF 18 1/2 X 52, DOUBLE HUNG
- 2. SPLC 34.11 (6), 34.34 (3) Provide service of heating facility by a licensed contractor which must include a carbon monoxide test. Submit a completed copy of the Saint Paul Fire Marshal's Existing Fuel Burning Equipment Safety Test Report to this office.
