Hello, my name is Don Jacobson. My address is 2106 Geranium Ave. E., St. Paul.

My 80-year-old mother, Connie Nardini, is a resident of On the Park Condominiums, whose sixth-floor kitchen window looks out onto the indoor atrium of Cray Plaza, which is currently leased by Faces Restaurant and its owner, David Fhima. Several months ago, Mr. Fhima and his associates began staging live music in this space, performances that included full bands with horn sections and amplified guitars. He did so without any prior consultation with the On the Park residents, who are separated from the atrium by merely a single pane of glass. Faces' "salsa nights" drew immediate complaints from my mother and other residents... the noise is intolerable and so loud that one has to shout to be heard within one's own condo. These big band performances lasted until 2 a.m., disrupting the residents' sleep.

Efforts to get Mr. Fhima and the individual working for him who stages these latenight parties to address the neighbors' concerns were met first with disdain and arrogance, Then there were promises to turn the noise down, which didn't stick. Then the neighbors discovered Mr. Fhima was operating these parties without an entertainment license. They only stopped when this was brought to the city's attention.

The fact is the design of the Cray Plaza complex -- with its residential elements basically sharing this indoor atrium with the commercial user -- makes any type of loud events in this atrium feel like they're happening right inside in the residences. The condos weren't built with the possibility of loud events in the atrium in mind. There is no soundproofing for them of any kind. The owners of Cray Plaza need to be aware of this when they write their next lease for the Faces Restaurant space and expressly prohibit amplified music in the atrium.

In the meantime, I strongly urge the city authorities to deny Mr. Fhima a license for use of the atrium as a late-night party zone. His practices are making my elderly mother's condominium uninhabitable on weekend nights and is placing her property value in dire jeopardy.
