CORRECTION NOTICE - RE-INSPECTION COMPLAINT

RE: 1009 THOMAS AVE

Dear Property Representative:

A re-inspection was made on your building on November 18, 2011, in response to a referral. You are hereby notified that the following deficiencies must be corrected immediately. **A reinspection will be made on or after December 15, 2011.**

Failure to comply may result in a criminal citation or the revocation of the Certificate of Occupancy. The Saint Paul Legislative Code requires that no building shall be occupied without a Certificate of Occupancy. The code also provides for the assessment of additional reinspection fees.

DEFICIENCY LIST

1. 2nd Floor - Rear Room - MSFC1026.1 - Provide and maintain an approved escape window from each sleeping room. The minimum size must be 5 square feet of glazed area with a minimum of 24 inches of openable height and 20 inches of openable width. With a finished sill height not more than 48 inches. This work may require permit(s). Call DSI at (651)- 266-9090. Refer to the Escape Windows for Residential Occupancies handout for more information.-
2nd Floor - Rear Room (Top of Stairway): Existing double-hung window has an openable area of 17 inches high by 17.5 inches wide and a glazed area of 42 inches high by 17.5 inches wide, 5.2 square feet.
Window replacement will require a building permit.
This work must be completed by November 11, 2011 per legislative appeal.
2. 2nd Floor - Rear Room (Top of Stairway) - SPLC 34.13 (1) - Provide and maintain all habitable areas with a ceiling height of 7 feet over 1/2 the floor area. - Height to finished ceiling is 6 feet 10.5 inches over most of the room.
3. Exterior - Rear - SPLC 34.08 (5), 34.31 (3) - Repair, replace and maintain all exterior surfaces on fences, sheds, garages and other accessory structures free from holes and deterioration. Provide and maintain exterior unprotected surfaces painted or protected from the elements. - Repair damaged and leaning fence.

4. Exterior - SPLC 34.08 (7) - All parking spaces shall be paved with asphalt, concrete, or durable dustless surfacing. Before any existing spaces may be paved, site plan approval must be obtained as specified in the St. Paul Zoning Code. Contact DSI Zoning at 651-266-9090.
