I am writing to register my objection to the application for a Liquor On Sale license by Double Black Diamond Inc., Red Cow on 393 Selby Ave in St. Paul, MN. The basis for this opposition is that granting a license for the incorporation will not promote a safe and healthy environment for our neighborhood. It does not help the prevention of crime and disorder, or people who may be struggling with addictions within our community.

393 Selby lies within a neighborhood that already has a wine store (Solo Vino, 517 Selby Ave.), a wine and spirits store (Selby Wine and Spirits, Inc., 778 Selby Ave.) and many restaurants/bars (Fabulous Ferns, Happy Gnome, W.A. Frost). Therefore, granting a license to Double Black Diamond Inc., (Red Cow) would only promote more alcohol use in our community. Our neighborhood already has numerous liquor license venues, we do not need another beer and burger restaurant.

393 Selby has the potential for being a great location for a non-profit organization or a non-commercial site. Some ideas that would benefit our community are: an elderly resource center, a public library or a historical, cultural museum of the people of African descent from the Selby and Rondo neighborhood areas.

We need to consider all populations of our neighborhood: including the youth at YWCA on 375 Selby Ave. and our student population at Walker West Music Academy on 760 Selby Ave. I am a resident of 370 Marshall Ave. and I object to granting a license to Double Black Diamond Incorporation, or Red Cow.
