

DESCRIPTION OF PROPOSED VACATION
 Vance Street and the Alleys contained within the plot of Northland Addition, according to the recorded plat thereof, Ramsey County, Minnesota.

GENERAL NOTES

- 1) Survey coordinate basis: Ramsey County Coordinate System
- 2) The easterly half of Block 20 was replatted as NORTHLAND ADDITION. No research was performed to determine whether or not the street and alleys dedicated in said NORTHLAND ADDITION were vacated.

UTILITY NOTES



- 1) Top of top nut of fire hydrant at the northwest quadrant of Bay Street and Jefferson Avenue Elevation = 102.51 feet
 - 2) Top of top nut of fire hydrant at the northwest quadrant of Bay Street and Palace Avenue Elevation = 102.47 feet
 - 3) Top of top nut of fire hydrant at the southwest quadrant of View Street and Palace Avenue Elevation = 106.01 feet
- NOTE: Elevations shown are based on City of St. Paul datum. Add 694.10 feet to convert to mean sea level datum.
