# Statement regarding Correction Notice for 306 George St. W

A couple, Ryan Woodworth and Nancy Vang, moved in to my rental house at 306 George St. W. on January 1<sup>st</sup>, 2017 and several days later they noticed two small very old dried roaches behind the back lit clock panel on the old electric stove. They notified me and I removed them promptly.

I purchased the house approximately 5 years ago and the stove in question was in the house from a previous owner. The remains of the those roaches were at a **minimum** 5 years old. There is not one other bit of evidence to indicate that there is or has been a roach in that house **ever.** It is my belief that the dried remains came with the stove whenever the stove was brought into the house.

Asking to have an extermination and a follow up inspection done for a false and mistaken reason would cause me undo financial hardship. The complaint was completely and utterly unfounded and irresponsible on the part of my tenant.

At the appeal hearing I will provide a signed statement from my previous four and half year tenant stating that at no time in the previous 4 and half years was there a roach ever seen in the house.
