Application for Appeal on Summary Abatement Order dated 9/5/23

My appeal will be about the ladders, tables, and wheelbarrows. It is my understanding that the ladders in the flower garden are considered ornamental according to two prior enforcement officers; however, the aluminum ladder was for painting. That has been put away.

Remedy for ladders: ladders have been chained together and secured and covered with chicken wire so no one can access the steps. It is a safety issue according to Victor Xiong and supervisor. That was by voice mail.

I also asked Victor via voice mail for the ordinance that allows ladders and decorational wheelbarrows in the yard. Currently there is nothing described that I am aware of specifically that wheelbarrows and ladders are recreational in a flower garden. I asked for that ordinance and have yet to receive that or any pictures that were mailed out with the summary abatement order. It is unclear if I had a fence if I would have to secure the ladders. Would that be appropriate? I am assuming that if you have a fence, people couldn't get to it. I lock my gates now.

I did ask Victor to check with the other inspectors about the ladders and wheelbarrows.

Remedy for wheelbarrows: As expressed before, have Victor ask other inspectors about the ladders and wheelbarrows provision.

The same goes with the tables. The picnic table is approved by the City. There are only 2 tables in the picture.

At the bottom of the summary abatement order, there is a header "APPEALS." It does not mention anything about waiving the fee. There is no mention of the fee.

Finally, I have attached correspondence from SMRLS dated 7/5/18. They do not provide any financial or legal support or both on summary abatement orders specifically.

I am still requesting a waiver and during the hearing a captioner, a tablet, and to save the transcript. And someone to send me the complete summary abatement order with all pictures in a timely manner as requested before. Manually check and send a fully accessible summary abatement order. Please note the current summary abatement orders does not include pictures.

You recently contacted Southern Minnesota Regional Legal Services (SMRLS) about a legal issue. We receive a limited amount of funding to advise or represent low income clients and people aged sixty and over.

We might have given you advice or legal information when you called. We can't help you further with this problem. Our guidelines must exclude many important legal problems. If you don't understand why we didn't take your case or if you have a complaint, call us again and ask for the person who is handling grievances.

You may want to contact an attorney in private practice. Two ways of finding an attorney are [www.mnfindalawyer.com](http://www.mnfindalawyer.com) and the local Yellow Pages. These attorneys will charge for their services. Contact an attorney right away. There may be a time limit to start your case or take some other action. You could lose your case if you miss a legal deadline.

SMRLS cannot specifically recommend or refer any private attorneys for your claim, but I strongly recommend utilizing available resources such as the Minnesota State Bar Association Attorney Directory to speak with a specialist (see attached link).
