## Greetings,

The St Paul Pioneer Press April 25, 2025 reported that the Breakaway Music Festival has requested a decibel sound variance for June 6 & 7, 2025 at Allianz field. The article went on to report that the St Paul city council had previously approved a variance of 103 decibels at 125 feet from the main stage, which is now being reconsidered to lowering to 100 decibels at 100 feet from the main stage per city staff recommendation.

I strongly encourage the city council to respect their staff's recommendations and lower the variance to 100 decibels at 100 feet from the main stage.

Rationale for this includes:

1) I live on the West Side of St Paul, and last year we were subjected to startling and onerous sound carryover miles away from the first Breakaway Music Festival. We couldn't get away from the sound even by moving indoors, even with the double paned windows closed in our house. I don't think we should be subjected to a repeat of this.

2) The decibel level of sound measurement is logarithmic, which means manifold more energy is generated per each decibel increase. This is well illustrated on the attached OSHA sound guidelines (see sound level vs recommended duration of exposure table). Please listen to your city staff's science based recommendations.

3) Frankly, I'm skeptical of Breakaway Music Festival's commitment to adhering to sound guidelines, evidence including last year's outrageous sound levels debacle. Also, if the Pioneer Press reporting is accurate, I find it insulting and extortionate that: "Organizers have said they may pull out if they don't get a higher sound limit than the decibel levels recommended by DSI".

Let them play music at a sound level confined to their paying customers, not provide free music to the entire city, which some of us don't want to listen to.
