I am writing to voice my support for granting a beer and wine license to Groundswell. My family and I live at 1331 Blair Avenue, two blocks away.

Expanding the Groundswell menu to include additional, higher-end food options, wine and beer will improve the quality of our neighborhood. Several of the best-respected neighborhoods in the Twin Cities, including Summit-University, Mac-Groveland and Merriam Park in St. Paul, feature casual restaurants of exactly the sort Groundswell wishes to become. These establishments are gathering places for individuals and families; they are ideal for the exchanging of ideas and the developing of new artistic partnerships. They give urban areas a vibrancy that makes them attractive to successful, educated buyers and renters, and creating such a space in the Midway will make nearby enterprises such as the Dreamland Arts theater true destinations for people from our neighborhood and from other parts of the Cities. Furthermore, the pedestrian traffic created by a successful restaurant of high quality contributes to public safety in a neighborhood at night.

Adding alcohol options is appropriate given the type of food Groundswell proposes to serve, and will make the restaurant more appealing for adult customers. Groundswell is aiming to become a casual bistro or cafe, not a bar, and its menu is aimed at responsible adults, not at students or people looking to drink to excess. The similar establishments I mentioned have not experienced problems related to the wine and beer they serve, and the higher prices of drinks at such places deters customers who might cause such problems.

The light rail is about to bring new opportunities for growth and revitalization in the Midway. We must make the neighborhood ready for it, and one of the best ways to do that is to elevate Groundswell into a top reason to visit or move here. I strongly encourage you to grant the restaurant the licensure it requests. Thank you for your time.
