NOTICE OF PUBLIC HEARING

Rhythm in Rice 2017 Sound Level Variance

Dear St. Paul Property Owner:

This is to inform you of a request for a variance from the sound level limitations as indicated in the St. Paul Noise Ordinance (Chapter 293 of the St. Paul Legislative Code). Property owned by you and located near the noise source, may be affected by this variance request. Rental property owners must provide a copy of this notice to all renters or post a copy in a common area of the building so it can be viewed by the occupants.

Description of Variance

Location: Rice Park

Noise Source: Brian Horst, B Horst Productions, has applied for a sound level variance, at a requested sound level of 90-100 dBA, at no specified distance, in order to provide music outdoors at Rice Park on twelve (12) Fridays beginning June 9 through August 25, 2017. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for amplified music for the hours from 6:30 p.m. until 9:30 p.m., with a pre-event sound check from 5:00 p.m. to 6:00 p.m., on twelve (12) Fridays beginning June 9 through August 25, 2017. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 90 dBA, as measured at 50 feet from the noise source from 6:30 p.m. until 9:30 p.m., with a pre-event sound check from 5:00 p.m. to 6:00 p.m. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 9:30 p.m. on each event date.
