LEGAL DESCRIPTION: PINs 28.29.22.41.0083 and 28.29.22.41.0095; Collings Addition of Outlots, Blocks 11-12, and Proetz Addition, Blocks 4-5

ZONING COMMITTEE ACTION: Recommended approval with conditions on March 9, 2023

PLANNING COMMISSION ACTION: Approved with conditions on March 17, 2023

CONDITIONS OF THIS PERMIT: Standard conditions specified in Sec. 61.501; Sec. 65.701; Sec. 65.705 and the following additional conditions:

1. Final plans approved by the Zoning Administrator for this use shall be in substantial compliance with the plan submitted and approved as part of this application.
2. An opaque fence must be installed along the Phalen Boulevard right-of-way to screen this use's vehicles awaiting repair.
3. All trash shall be stored within an enclosed obscuring wall or fence, shall not exceed the height of the wall or fence, and shall be removed from the lot by licensed waste disposers at least once per week

The decision to grant this permit by the Planning Commission is subject to appeal to the City Council. Anyone affected by this action may appeal this decision by filing the appropriate application and fee at the Zoning Office, 1400 City Hall Annex, 25 West Fourth Street. **Any such appeal must be filed within 10 calendar days of the date of the Planning Commission's decision.**

Violation of the conditions of this permit may result in its revocation.

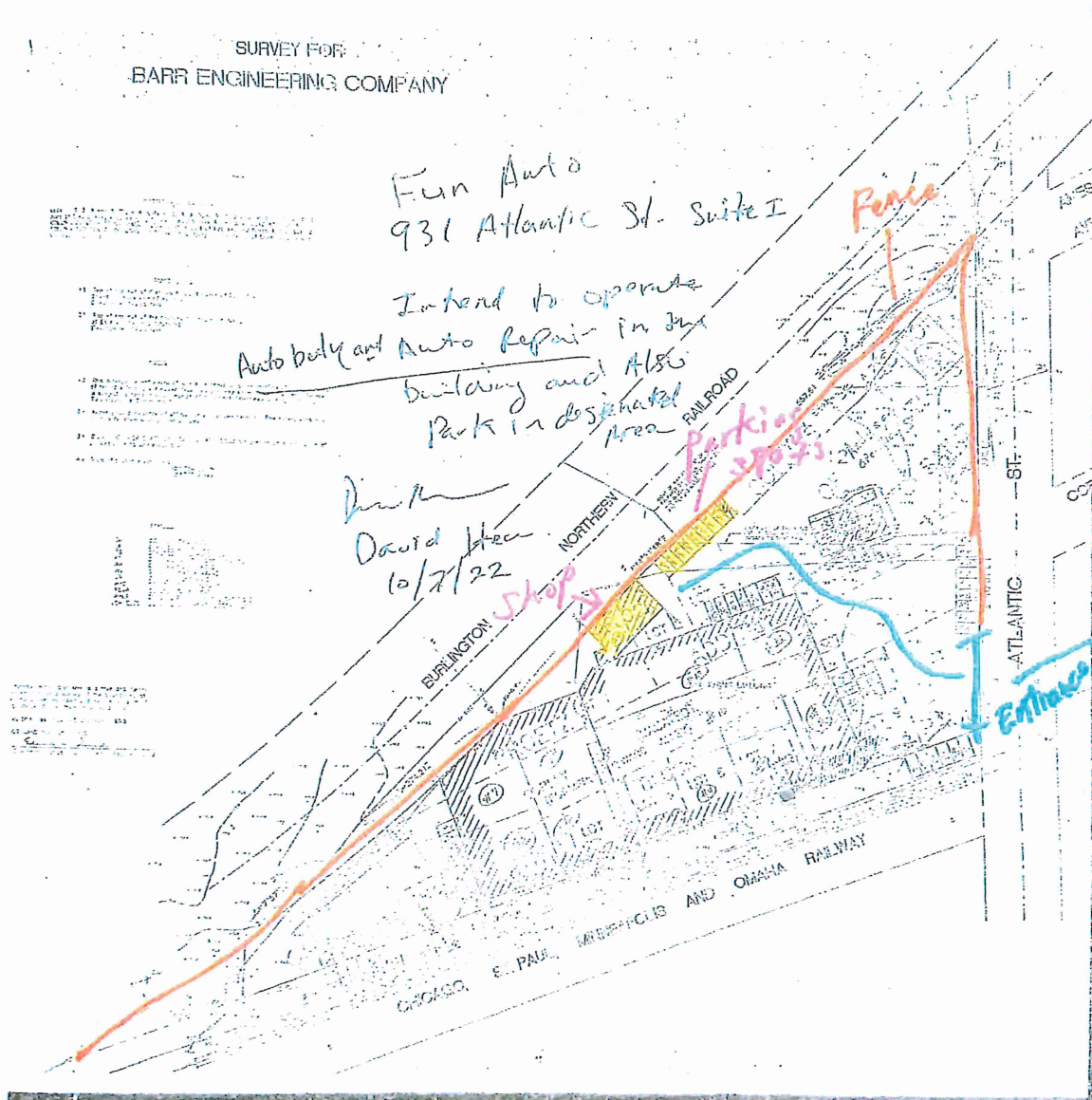

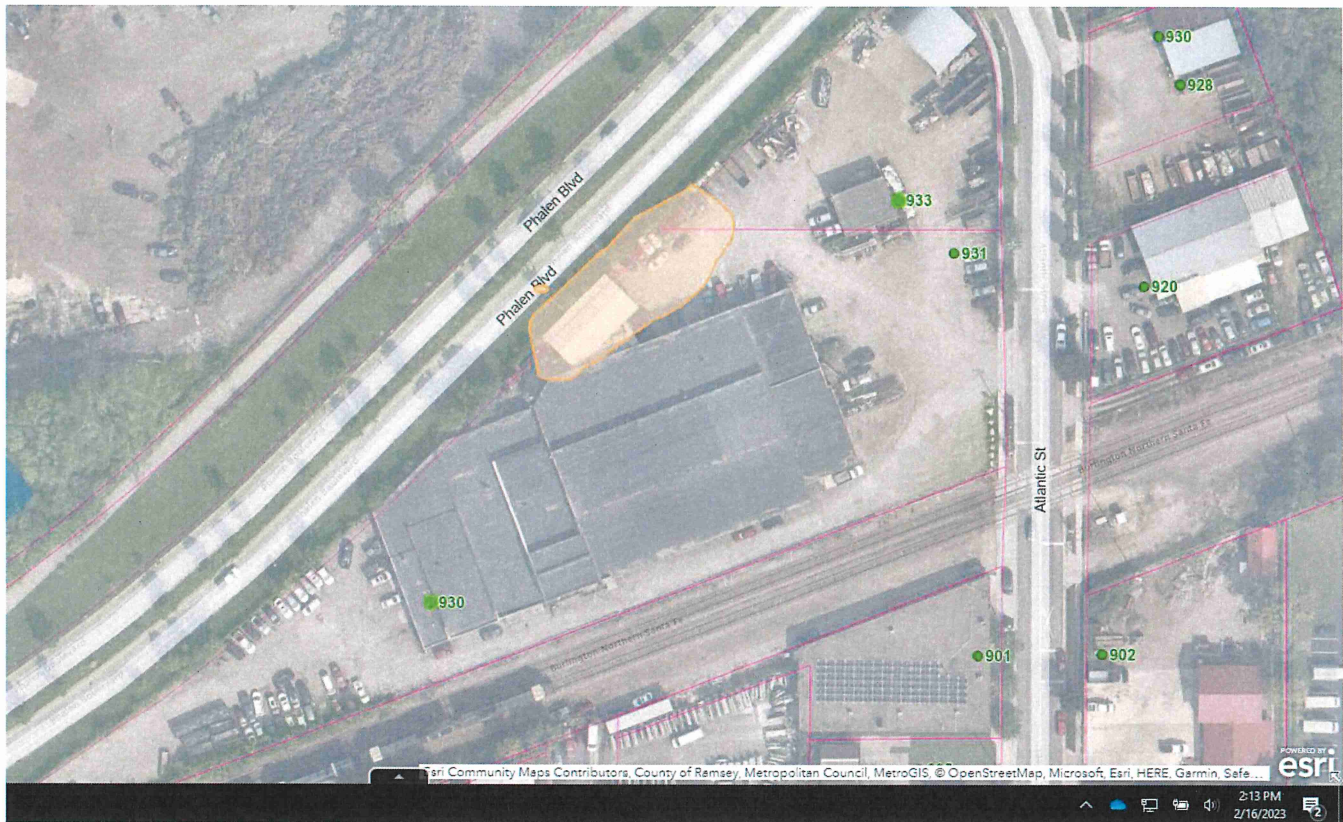
