

SUMMARY OF ENGINEERING RECOMMENDATION
Reconstruction at 1067 Hudson Road

PROJECT:

This project is to reconstruct the boulevard sidewalk in front of 1067 Hudson Road during the citywide sidewalk reconstruction.

EXISTING CONDITIONS:

Boulevard sidewalk needs reconstruction work to correct defective sidewalk panels.

INITIATING ACTION:

This order was initiated by Public Works in agreement with the Property Owner. Public Works agreed to perform the work with the Property Owner paying the costs. Property Owner has signed a Waiver of Notification to allow Public Works to reconstruct the additional boulevard sidewalk panels in front of their property during the 2014 construction season.

The project to be done during the 2014 construction season.
