Location: 400 Snelling Ave. N. – Amplified sound within the Street and the Beer Garden Area outside of Allianz Field

Noise Source: Zacharia Litzelswope, MNUFC Director, Events and Guest Experience, has requested two sound level variances, for 95 dBA at no specified distance to present amplified sound with use of a sound system for the MNUFC v Orlando game and for the MNUFC v FC Dallas game at 400 Snelling Ave. N- Amplified sound within the Street and the Beer Garden Area – outside of Allianz Field. The variances are requested for the hours of 4:00 p.m. to 7:30 p.m. with a pre-event sound check at 3:00 p.m. on April 15, 2023 and for the hours of 4:30 p.m. until 8:00 p.m., with a pre-event sound check at 3:30 p.m. on April 30, 2023. The Department of Safety and Inspections will be recommending the following conditions: 1) The Variances shall be for the hours of 4:00 p.m. to 7:30 p.m. with a pre-event sound check at 3:00 p.m. on Saturday, April 15, 2023 for the MNUFC v Orlando game and from 4:30 p.m. until 8:00 p.m. with a pre-event sound check at 3:30 p.m. on Sunday, April 30, 2023 for the MNUFC v FC Dallas game. 2) All electronically powered equipment used in conjunction with the event shall not exceed 90 dBA as measured at 50 feet from all sound sources on April 15, 2023 and on April 30, 2023. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 7:30 p.m. on April 15, 2023 and no later than 8:00 p.m. on April 30, 2023.

Submit comments for Public Hearing electronically. The public may comment on public hearing items in person, in writing or via voicemail. Any comments and materials submitted by 12:00 pm of the day before the meeting, Tuesday,

March 7, 2023, will be attached to the public record and available for review by the City Council. Live testimony will be taken in person in the Council Chambers, and by telephone by registering to speak by noon on the day before the meeting. 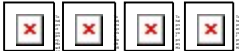
