## CITY OF SAINT PAUL, MN PROPOSED 2025-2029 CONSOLIDATED PLAN AND 2025-2026 ANNUAL ACTION PLAN REVIEW AND NOTICE OF PUBLIC HEARING

In accordance with 24 CFR 91.105(b)(2) of the Consolidated Submission for Community Planning and Development Programs Final Rule, the City of Saint Paul will have its proposed 2025-2029 Consolidated Plan and 2025-26 Annual Action Plan available for review and comment from March 10, 2025 to April 9, 2025.

The Consolidated Plan is a five-year plan required by the U.S. Department of Housing and Urban Development (HUD) to receive approximately \$9 million in Federal funds through the Community Development Block Grant (CDBG) Program, Home Investment Partnerships (HOME) Program, and Emergency Solutions Grant (ESG) Program. The plan outlines priorities for housing, economic development, infrastructure, and public services needs in alignment with the policies and implementation actions established in the City of Saint Paul's 2040 Comprehensive Plan. The Annual Action Plan is an application to HUD for funding under the federal programs referenced above and serves as the City's planning document for the use of these funds during the 2025-26 program year.

The City has made a change to its Citizen Participation Plan to establish procedures for expedited response to disasters. The proposed 2025-2029 Consolidated Plan and the 2025-26 Annual Action Plan with the amended Citizen Participation Plan is available for review at <u>https://www.stpaul.gov/conplan</u>.
