L Remarks: Crews were dispatched to a 3 story apartment building with smoke coming out the Charlie side door. On arrival, crews found heavy smoke coming from the garden level apartments. Engine 17 made initial entry with a 1 3/4 preconnected hose line for primary fire attack, followed by Engine 22 with a back up hose line. Squad 1 started a primary search of second and third floors. Engine 22 reported all clear fire room. Squad 1 finished primary search of garden level apartments and received an all clear on all floors. Ladder 22 was initial R.I.T. company and Ladder 8 assisted with ventilation. Engine 8 established a water supply to Engine 22 and Engine 17 and Engine 9 set up for a second water supply if needed. Deputy Chief-Car 5 was the safety officer and Medic 6 captain was F.I.T. Engine 8 and Engine 9 preformed secondary search on all floors and all clear. Safety reported fire in walls on Alpha and Bravo sides of the structure. Engine 8 opened up walls in Apartment 3 to find fire in the pipe chases. The fire was extinguished and overhaul begun. Squad 2 began the investigation duties with assistance from Squad 1. D.S.I. Inspector 12 responded with the building owner and occupants on scene. Red cross was called for 28 residents and board up to secure the structure.
