NARRATIVE

We, Sgd 319 (Bolduan/Lewis) went to 735 N. White Bear (Cherry Pit) on a proactive visit. We were informed by Sgd 303 (Sgt. Lambie) that licensing had been receiving complaints of after hours drinking at the bar.

We checked out on scene at 0236 hours. We observed numerous cars in the back parking lot and several in the parking lot directly across the street of the front entrance of the bar on White Bear. I (Off. Bolduan) went to the front door of the business and Officer Lewis went to the large window on the White Bear side of the business (see his supplement).

I heard music coming from inside of the bar. I knocked numerous times but did not get an answer. After several more attempts, Officer Lewis shined his flashlight into the bar to get the attention of the people who were still inside. Officer Lewis then told me that one of the male's sitting at the bar had been drinking out of a bottle.

I identified that male by MN dl as Michael William Engelking (01-24-63 4724 Krech Ave White Bear Lake, MN 55110.) He admitted us that he was drinking alcohol in the bar just before they let us in. He said he was an employee of the bar, but was not working tonight.

Another employee said it was there employee Christmas party tonight in the basement. I explained to him that we had been getting complaints of after hours drinking inside the bar. He said he knew of the complaints, and that officers had been stopping nightly to do compliance checks, He said he thought the bar had fixed the problem.

He did say that he does bartend at other places and knows what time serving alcohol ends. He apologized and said he thought things would be more lax tonight because it was their employee Christmas party.

I explained to everyone inside the bar that we would be writing a report on the violation and sending it to licensing.
