This is a common sense and practical measure to help ensure gun safety and to aid in the prevention of possible gun violence. There is a wealth of data and evidence surrounding the potential for serious harm when firearms and ammo are not properly secured. There are those, like the MN Gun Owners Caucus, that will imply this impedes on civil/personal liberties, which is asinine and dangerous. If someone chooses to own a firearm, that is their choice, but as a society we have to have real and practical expectations of how something as serious as a gun should be handled from storage to maintenance to actual usage.

I've lived in Minneapolis and St. Paul for about 15 years now. Much of my upbringing was down in Dodge County. I grew up in Dodge Center and Kasson-Mantorville. Fairly small farm towns. I grew up with many families that are gun owners and hunters. They were in gun safes or gun lockers, secured, ammo was stored separately, also secured many times. Chambers loaded with dummy rounds, etc. My point is this: any person that comes to argue that this is against "liberty" or not what gun ownership is about is simply trying to force the dangerous and reckless notion that gun ownership should be more casual, more relaxed, and frankly, more flaunted. It's a gun culture mentality that is permissive and obsessive and a danger.

I've grown up with hunters, military veterans, and folks in the national guard. I have never heard a single one talk about gun ownership in such casual terms or remark that anything like this ordinance would be "oppressive." They would all, to the last person, say it is incredibly serious, and firearms should always be stored and secured for safety.

On the flipside, I have also seen more reckless and casual gun owners. It is deeply concerning. It can lead to horrible accidents and tragic loss of life.

The Minnesota chapter of the American College of Physicians (MN-ACP) represents nearly 2500 statewide internal medicine physicians and internal medicine trainees. We represent over 180 members who live or practice in St Paul.

MN-ACP is concerned about the rising number of firearms-related injuries and deaths in our cities, state, and nationwide. **In Saint Paul alone, there were 217 gunshot wounds and 32 homicides in 2022.** *As physicians, we see first-hand the devastating impact of such violence on our patients and their families.* We are the ones who often inform and counsel families that have lost a loved one; we treat survivors of firearms violence who often face lifelong disabilities and trauma, and we treat their family members. *Many of these deaths and injuries from firearms are preventable if lawmakers would work together to pass meaningful reforms to keep firearms safely stored from those at the greatest and most immediate risk of harming themselves or others, while respecting and preserving second amendment rights.*

We strongly support the proposed amendment (Ord. 23-22) to Chapter 225. The rising trends for firearms not safely stored in St Paul is alarming:

- In the City of Saint Paul, injuries and homicides resulting directly and indirectly from firearms discharge have continued to increase with 191 gunshot wounds and 29 homicides in 2020, 205 gunshot wounds and 30 homicides in 2021 and 217 gunshot wounds and 32 homicides in 2022;
- The number of firearm incidents occurring in Saint Paul schools was 2 in 2020, 3 in 2021 and increased to 8 in 2022 (8); and
- In 2022, of the 603 firearms recovered by the Saint Paul Police Department, firearm theft from auto is the highest count for stolen firearms at 97.

The proposed amendment is for responsible gun ownership practices through safe gun storage, securing ammunition and including gun lock devices which can reduce and prevent the tragedies associated with the discharge of firearms left unsecured. For those who are opposed to safe firearm storage when they travel through or visit St. Paul, this ordinance is as much about reducing injury/death as it is about reducing firearm theft.
