On Wednesday, April 26<sup>th</sup>, 2023 the Housing and Land Use Committee ("HLU") of the Macalester Groveland Community Council ("MGCC") held a public eMeeting via Zoom, at which it considered the draft policy for Unmanned Aircraft Systems (UAS).

After considering neighborhood and committee feedback and assessing the draft policy, the Housing and Land Use Committee passed the following resolution unanimously by a final vote of 10-0:
