Team Ortho Foundation has requested a sound level variance to provide the use of a sound system for post-race announcements and a DJ at Upper Landing Park for the Women Rock MN Race Event. The variance is requested for the hours of 8:00 a.m. until 1:00 p.m., with a pre-event sound check at 7:45 a.m. on Saturday, August 27, 2016. The Department of Safety and Inspections will be recommending the following conditions: 1) The variance shall be for the hours of 8:00 a.m. to 1:00 p.m., with a pre-event sound check at 7:45 a.m. for the Event on Saturday, August 27, 2016. 2) All electronically powered equipment used in conjunction with the event shall not exceed 85 dBA as measured 50 feet from any sound source used for music and/or announcements. 3) The applicant shall provide personnel and equipment to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 1:00 p.m. on the date of the event.

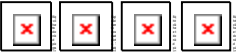
