## Staff Comments

During initial assessment inquiry, Republic stated the \$25.34 consists of \$13.44 in late fees from Quarter 1 2024 which were not sent in for certification, along with a \$8.60 charge for bags from Quarter 1 2024 and \$3.30 late fee charges for the bags and uncertified Q1 charges.

I bought the house in March 2024 and did not move in until September 2024. After closing the home, I went on a vacation, and when I returned there wasn't a garbage disposal trash bin sitting in my driveway after 1-2 weeks of purchasing the home, so I don't understand how I can be charged for a service I wasn't even receiving in the first place. I had to carry all my garbage to my old house to be disposed of in that garbage trash bin. Never received a garbage bill from Republic Services from April - August. The only notification I received and finally notified of this was from St. Paul City in August 2024. I called and spoke with a rep, Jillian Barden from St. Paul City who was kind enough to explain the trash regulations in the city, and that there was a collection because of an unpaid bill and stated she would try and get more information on why I was never informed of this garbage bill until August 2024 through the city instead of Republic Services.

Per her email reply (attached below), the bill is from Q1. The fees are extra bags, cancellation fees, and late fees which are not mine. As I mentioned, I never utilized a garbage trash bin on this property until I recently activated it

in 09/2024 because I did not live in the home. I called Republic Services in mid-August 2024, and they did not see any outstanding balances on their end under my name and was told by the rep that my account is up to date.

Hi again Roseline

It appears that the Quarter 2 (April - June) 2024 invoice of \$25.34 for this property was not paid by the previous property owner. Republic Services sent your delinquent Quarter 2 (April - June) bill to the City which the City paid on behalf of the previous property owner. Therefore, the assessed amount of \$25.34 is still due to the City of St Paul. **Unfortunately, as the current property owner you are now responsible for any assessments on the property.**

Our recommendation to new homeowners in similar situations is to contact your title specialist as they should have informed you about this assessment before closing on this property and addressed it at closing.

Republic Services cannot bill late fees from Quarter 1 onto the Quarter 2 bill. I have requested they removed the charges of \$13.44 from the assessment. As for the extra bags, you could try and go through your title company to see if they will pay for the charges, because it is from when the previous owners lived there. We usually recommend this in a case like yours.

If you are not in agreement with this recommendation, you can further contest this assessment at your scheduled legislative hearing on October 17. Please reply to this email if you would like to do so.
