Hello everyone,

We hope your summers are going well! The AZA Annual Conference is fast approaching, and we would like to extend a great opportunity to our ACE for Wildlife network partners! Thanks to a generous grant from ACE for Wildlife's funding partner, Woodland Park Zoo is able to support the participation of two staff members from each partner organization at the AZA Conference this year. ACE for Wildlife is able to reimburse each organization for up to two staff members; we will reimburse a \$550 early registration for each member as well as \$500 to cover other travel costs. Don't forget to register your attendees no later than Aug 9 to take advantage of the early registration rate. As we would like to use the time on Saturday, August 7, for a discussion of the plans for ACE for Wildlife, we ask that you please send attendees that will be central to the empathy work you're doing and able actively help shape this network.

We expect that participating partners will attend [an Advancing Conservation Through Empathy for Wildlife Partner Meeting, Saturday, September 7, 10:00 am – 12:00 pm at the Convention Center](#): Again, please plan on only two attendees per organization at this meeting, given space limitations at the venue. The goal of this discussion is to define the ACE for Wildlife network structure and discuss possible governance frameworks moving forward. This discussion will be a precursor to ongoing network discussions at the 2020 symposium (stay tuned for a save the date in Q1 2020!) so please plan on sending staff members who can speak to your organization's empathy-based work and possible role in the network next year.

In addition, [ACE for Wildlife will be hosting a booth](#) in the exhibit hall. While membership in the network is not currently open to all AZA organizations, we would like to share what we know about the empathy with the AZA network and highlight the work that the partners are doing in our region. We would like your help staffing the booth. Woodland Park Zoo will make sure that there is one person staffing the booth during open hours, but we'd like to invite attendees from all organizations to sign up for 1-2 hour shifts to talk about their organizations' perspective on the network.
