Dear City Clerk,

Please accept these comments, along with the attachment, for posting to the public record.

[RES PH 25-284](#) appears to authorize the police department to increase overtime spending by \$1,545,000 for security at special events.

My understanding is that security for these special events is paid for by the outside special event requestor(s) such as marathons, concerts, winter carnivals etc.

The Police Department Community Engagement account number 10023500, funded by the City's General Fund, was approved by the City Council in the amount of \$10,265,487 for 2025.

RES PH 25-284 would increase this amount by \$1,545,000 for a total of \$11,810,487 (Not all of this total amount is for overtime security at special events but at least \$1.5 million is).

As shown within my attachment below, I've requested data pertaining to these special events, the security overtime and the revenues received from the outside special event requestor(s).

OFS indicates they cannot respond in time for Wednesday's public hearing.

Without a response from OFS it is difficult to determine where this money is coming from: the special event requestor(s) or from an excess of funds now available within the overall City General Fund?

If the latter, the City Council might consider the fairness of why some special event security overtime might be paid by the special event requestor(s) while other special event security overtime might be paid by taxpayers.

(A special fund that keeps account of these transactions would be a suggested help.)

Also, RES PH 25-284 cites City Charter authority under [Chapter 10.07.1](#) which requires this public hearing.

But the resolution's financial [attachment 1](#) cites authority under [Chapter 10.07.4](#) which would not appear to require a public hearing.

Attachment 1 also cites City Administrative Code Section [57.09\(3\)](#) which appears to apply only to capital improvement budget amendments.

Regardless of which procedures are being followed, I would very much appreciate the Council for considering these comments, so that police security overtime for special events can be better understood by everyone.

To that end, I request that the City Council keep the public hearing on this matter open until OFS and SPPD are able to respond.
