Noise Source: Maureen McGuire and Andrew Dull have requested a sound level variance, at a requested sound level limit of 85 dBA at no specified distance in order to present outdoor ambient music with speakers from 6:00 p.m. until 10:00 p.m., with a pre-event sound check from 5:00 p.m. until 6:00 p.m. on September 10, 2016 at 666 Fairmount Avenue. The Department of Safety and Inspections (DSI) recommends the following conditions: 1) Variance will be for outdoor ambient music with speakers for the hours from 6:00 p.m. to 10:00 p.m., with a pre-event sound check from 5:00 p.m. until 6:00 p.m. on Saturday, September 10, 2016. 2) All electronically powered equipment, PA systems, loudspeakers or similar devices used in conjunction with the event must not exceed 85 dBA at 50 feet from the noise source from 6:00 p.m. until 10:00 p.m. 3) The applicant shall provide personnel and equipment who will provide sound level monitoring to ensure compliance with the sound level variance conditions. 4) All electronically powered equipment, PA systems, loudspeakers or similar devices shall be turned off no later than 10:00 p.m. on Saturday, September 10, 2016.

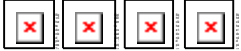
If you attend the public hearing, you will be given the opportunity to present verbal comments or objections before the City Council.
