Dear City Council and Clerk of the Council:

My wife and I live at 6 Edgcumbe Place in Highland Park for the last 30 years, we want you to know that we, like the rest of the property owners on Edgcumbe Place want the city's reconstruction of Edgcumbe Place to follow the road as currently constructed and not as erroneously described in the legal description that the Public Works people apparently intend to use. The proposed City Council project will destroy decorative walls, fences; and serious crowding of one of the homes.

The proposed City Council project also will destroy mature trees, affecting the nature and the environment

The solution is to move the faulty easement, not to move the road. We seven neighbors are willing to grant a Corrected Easement to allow a new road to follow the existing road, not the mistaken easement. This is the least expensive and least damaging approach to our special little road.

Please do not approve the proposed changes to Edgcumbe place until the staff has shown us the proposal and made the changes necessary to cost effectively meet our needs.
