The ordinance (LC348.01) requires 75% in order to grant the license. Note: There are a number of other items which have not been provided (required parking for one) but are not necessary unless a license is issued and the business is legally able to operate. CAR

08/10/2011 No response to 07/22/2011 orders. File given to CAR for review and possible adverse action. JWF

07/22/2011 Orders issued, submit petition information by 08/05/2011, and complete remaining unmet requirements (DSI Zoning inspection approval, submit business plan, DSI Animal Control inspection approval) to obtain license by 08/26/2011. JWF

05/10/2011 Emailed Jane Prince of status of petition, and advised of other outstanding unmet requirements (submit written business plan, Animal Control inspection approval, and DSI Zoning Section site plan approval (need to provide 4 off-street parking spaces)). Recheck 06/30/2011. JWF

05/09/2011 Per email from Jane Prince, attorney representing applicant, one additional signature submitted towards petition requirements. Now have 6 out of 9 possible signatures, or in other words 66% support. Need one more signature to meet at least 75% support (required minimum per Code). JWF

04/01/2011 Email sent, submit two additional supportive signatures

01/05/2011 Council File #11-11 approves appeal of PC Resolution #10-506183 decision. This approval permits the addition of a pet day-care and pet boarding service to the pet grooming business subject to the addition of . JWF

12/16/2010 Per email to Jane Prince, research of property sales records and Ramsey County ownership records, the property in question (377 Fulton St) has changed ownership as of 05/27/2010, and will count towards meeting petition requirements. Need 2 additional signatures to meet petition requirements. JWF

11/12/2010 Jane Prince, attorney representing applicant, stated one of the owners of a property needing to sign petition has died, and they cannot find a representative for that property. Ms. Prince requests that property be excluded from counting toward petition requirements. JWF

11/03/2010 CC approves appeal permitting animal boarding. JWF

09/20/2010 Appeal of PC decision to CC submitted to PED, scheduled for CC on 11/03/2010. JWF

09/10/2010 PC denied request to add animal boarding and/or day care. JWF

09/02/2010 Zoning Committee recommends Planning Commission (PC) deny request to add animal boarding and/or day care. PC hearing scheduled for 09/10/2010. JWF

08/12/2010 Letter sent to licensee reminding of need for license before establishing animal day care and/or boarding use, that an animal day care (if approved by Planning Commission) requires separate license, and that her petition is short by two signatures. JWF

08/05/2010 Planning Commission has laid over the change of nonconforming use permit request to add dog boarding operation. Appears may be leaning towards only allowing day care. JWF

02/02/2010 No recent contact from Sandra Belisle with PED regarding establishing City Zoning approval for dog boarding operation. To CAR for review. JWF

01/05/2010 Per Corrine Tilley, Sandra Belisle called and stated she would try to obtain PED approval (e.g., rezone the property) for dog boarding operation. Emailed CAT. JWF

01/04/2010 Emailed PED (Patricia James and Paul DuBruiel) if anyone has contacted them regarding legalizing the pet boarding business operation. Per PED nobody has contacted them regarding this subject as of this date. File to CAR for review. JWF

12/30/2009 Kris Schweinler spoke with Sandra Belisle who requested more time to complete petition requirement. Kris explained that even if petition requirement is met she would still need to meet other requirements referenced in letter, which includes obtaining DSI Zoning Section approval and recommended she speak with Corinne Tilley, DSI Zoning Section. Corinne Tilley spoke with Sandra Belisle and told her to add this use to her existing nonconforming use, she would either need to rezone the property or obtain a new nonconforming use permit. Corinne explained this would be handled through PED and recommended she contact them (provided the general number). JWF

12/04/2009 Orders issued incomplete application submit additional information, and obtain DSI Zoning approval. Response date 12/31/2009. JWF
